### INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA

**GENERAL NOTICE ON LICENCE CONVERSION IN TERMS OF  
SECTION 93 OF THE ELECTRONIC COMMUNICATIONS ACT, 2005  
(ACT NO. 36 OF 2005)**

### **SCHEDULE 1**

**CONVERSION OF VALUE ADDED NETWORK SERVICES LICENCES  
TO ELECTRONIC COMMUNICATIONS NETWORK SERVICES.**

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has resolved to convert all Value Added Network Services ("hereinafter referred to as VANS") Licences to both Electronic Communications Services (hereinafter referred to as ECS) Licences and Electronic Communications Network Services (hereinafter referred to as ECNS) Licences in terms of section 93 of the Electronic Communications Act (No 36 of 2005) (hereinafter referred to as the Act).
2. The Authority hereby invites written representations from the interested parties on the proposed process for converting VANS licences into ECNS licences.

### **3. PROPOSED FRAMEWORK IN TERMS OF SECTION 93 (3) OF THE ACT FOR CONVERTING VANS LICENCES TO ECNS LICENCES.**

3.1 The Authority will convert all VANS licences, including licences granted after 19 July 2006 to ECNS licences.

3.2 The Authority will require the following information to be submitted in terms of Section 93 (3) (c) of the Act together with the written representations to the proposed framework.

- (i) Full name of the Licensee;
- (ii) Shareholding details of the Licensee expressed in percentages;
- (iii) Details of ownership by historically disadvantaged individuals expressed in percentages;
- (iv) Full Names, telephone and cell phone numbers of the contact persons;
- (v) Postal and Physical addresses of the licensees;
- (vi) Whether the Licensee prefers to be converted to Class or Individual ECNS;
- (vii) The Licensees are required to indicate proposed Geographic Coverage Area, whether they intend providing electronic communications network services of national or provincial scope and specify areas to be covered;
- (viii) Proposed obligations in terms of section 93 (4) (b) of the Act:
  - (a) Licensees should undertake to commence with the rollout of network within 12 months of the licence being issued.

- (b) Licensees must submit a comprehensive technical plan, including propagation analysis, for the purpose of Authority's monitoring and information.
- (c) Licensees are required to indicate voluntary obligations on how they intend to contribute to social and economic development of the Republic of South Africa.

3.3 The draft ECNS licence is annexed hereto as **Annexure A and B**.  
Written representations are also invited in respect of the proposed draft licence.

3.4 The Authority proposes the following timeframe for conversion of VANS to ECNS:
