The above matter refers.

Kindly find enclosed herein the written representations submitted by Telkom SA Limited ("**Telkom**") in response to the Authority Discussion Document *gazetted* pursuant to Government Gazette No. 34382 of 22 June 2011.

In making these representations, Telkom has alluded to information that would ordinarily be characterised as confidential information due to its commercial and very sensitive nature. Furthermore, Telkom considers that this information amounts to such in terms of section 4D(4) of the ICASA Act, 2000, and in particular subsections (4)(b), (c) and (e). The nature of this information is inherently commercially sensitivity and Telkom has elected to share the information with the Authority *in good faith* and *without prejudice* as part of the public consultative process.


