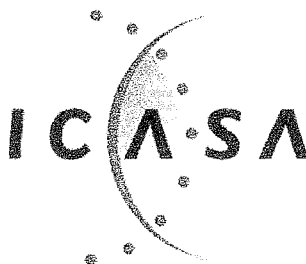

EXTENSION OF THE CLOSING DATE FOR SUBMISSIONS OF COMMENTS REGARDING THE DRAFT REGULATIONS FOR THE TYPE APPROVAL OF ELECTRONIC COMMUNICATIONS EQUIPMENT AND ELECTRONIC COMMUNICATIONS FACILITIES AND THE CERTIFICATION OF TYPE APPROVED EQUIPMENT

1. The Independent Communications Authority of South Africa ("the Authority") hereby, gives notice of an extension of the closing date for submission of comments published in General Notice No.1068 in Government Gazette No. 36046 dated 28th of December 2012.
2. The closing date for the submission of written representations by interested persons, including an electronic version of the representation in Microsoft Word, of their views on the draft regulations for the Type Approval of electronic communications equipment and electronic communications facilities and the certification of Type Approved equipment regulations is extended from 16h30 on Friday, 15 February 2013 to no later than

16h00 on Friday, 22 February 2013.

6. All written representations submitted to the Authority pursuant to this notice shall be made available for inspection by interested persons from the 25th of February 2013 at the ICASA Library or website and copies of such representations and documents will be obtainable on the payment of a fee.

Where persons making representations require that their representation or part thereof be treated as confidential, then an application in terms of section 4D of the ICASA Act, 2000 (Act No. 13 of 2000) must be lodged with the Authority. Such an application must be submitted simultaneously with the representation on the draft regulations and plan. All confidential material must be pasted onto a separate annexure which is clearly marked "Confidential". If, however, the request for confidentiality is not accepted by the Authority, the person making the request will be allowed to withdraw the representation or document in question.
