

**ERRATUM OF GOVERNMENT GAZETTE NO. 48352 (NOTICE NO. 3242) OF 31 MARCH  
2023:  
DISCUSSION DOCUMENT ON DYNAMIC SPECTRUM ACCESS AND OPPORTUNISTIC  
SPECTRUM MANAGEMENT**

1. On 31 March 2023, pursuant to section 4B of the Independent Communications Authority of South Africa Act (Act No 13 of 2000) (“ICASA Act”), the Independent Communications Authority of South Africa (“the Authority”) published the Discussion document on Dynamic Spectrum Access and Opportunistic Spectrum Management for Public Consultation in Government Gazette Number 48352 (Notice 3242).
2. The closing date for the submission of the written representations, in response to the above notice, was 12 May 2023, which is 27 days from the date of publication of the notice.
3. Section 4B (2) of the ICASA Act requires the Authority to, amongst other things, give notice in the Gazette of its intention to conduct an inquiry and invite interested persons to submit written representations on or before a date specified in the notice, which date may not be less than 45 days from the date of publication of the notice. Accordingly, the closing date for the receipt of the written submissions is **7 June 2023**.
4. The Authority would also like to take this opportunity to extend the closing date for the receipt of written representations to **26 June 2023, 16h00**. The extension will allow interested persons to make substantive written representations considering that they may not have been able to do so due to the error with the initial closing date.
5. Interested persons that have already submitted written representations may supplement or resubmit their written representations, should they wish to do so, on or before 16h00 on **26 June 2023**.

The Authority apologises for the error and the inconvenience this may have caused.
