NOTICE OF EXTENSION OF THE CLOSING DATE FOR WRITTEN SUBMISSIONS TO THE DRAFT RADIO FREQUENCY ASSIGNMENT PLANS (RFSAP) FOR INTERNATIONAL MOBILE TELECOMMUNICATIONS (IMT) BANDS AND THE DRAFT EXCLUSIVE GEOGRAPHIC AREAS FOR THE RFSAPs FOR IMT BANDS IN THE MILLIMETER WAVES PUBLISHED IN THE GOVERNMENT GAZETTE NO. 55046 OF 2026.

1. On 24 July 2026, the Authority published the RFSAP for IMT bands and Exclusive Geographic areas for the RFSAP for IMT bands in the mmWaves for consultation in the Government Gazette No.55046 (Notice 190; 210; 308; 353; 372; 394; 413; 433; 453; and 473 of July 2026).
2. Interested persons were invited to submit written representations, including an electronic version of the representation in Microsoft Word, of their views on the Draft IMT Roadmap by no later than 16h00 on Friday, 04 September 2026.
3. The Authority has received and considered a request for extension. Further, the Authority has decided to grant an extension for submissions to Friday, 30 October 2026 no later than 16h00.

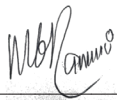

5. All written representations submitted to the Authority pursuant to this notice shall be made available for inspection by interested persons from 02 of November 2026 at the ICASA Library or website and copies of such representations and documents will be obtainable on payment of a fee.
6. Where persons making representations require that their representation, or part thereof, be treated confidential, then an application in terms of section 4D of the ICASA Act, 2000 (Act No. 13 of 2000) must be lodged with the Authority. Such an application must be submitted simultaneously with the representation, together with a non-confidential, redacted version of the submission.
7. If, however, the request for confidentiality is not granted, the person making the request will be allowed to withdraw the representation or document in question. The guidelines for confidentiality requests are contained in Government Gazette Number No 41839 of 17 August 2018.
